UPIX Networks expands its network coverage in Brazil with Padtec's DWDM solution

Campinas/SP, September 4, 2023 – PADTEC HOLDING S.A. "One of the most recent technical novelties of this generation of transponders is the Coupled Mode functionality, which enables intermediate transmission rates, for example 50, 150 and 250 Gb/s, and not just in increments of 100 at 100 Gb/s", explains Argemiro Sousa, Chief Operations Officer for Equipment at Padtec. "For our customers, this means more flexibility and lower cost per bit for expanding the capacity of their networks", he concludes.
